As mentioned in our last newsletter, celebrations and holidays have been overshadowed by the threats to our community by "over the top" development proposals at both ends of the Bay. Those of you who have been at Catho during the past week will have seen that the banners that were so effective in our past campaigns have been spruced up and supplemented by a whole raft of new slogans.

Members have also been on the beach over the holidays and will be out for the 2011 Catho Classic surfing competition on 7-9 January informing people of the current development proposals, In particular we are asking people to voice their opinions on the latest Rose Group project application for 600 suburban lots proposed around the southern end of the village of Catherine Hill Bay.

But if that were not enough, we have now been advised that LakeCoal propose to demolish the jetty in the next few months before returning the leased area to the state! This has also been put on public exhibition and we need to respond within the coming weeks.

Save Catho - Save the Jetty

"The beach with the jetty" is how many people know Catherine Hill Bay. The jetty is *the* symbol of the Bay and is loved by surfers, fishers, scuba divers, locals and visitors alike. It was listed as an item of heritage significance in the *Lake Macquarie Local Environment Plan* in 2004, and voted an icon by the people of the Hunter Region in 2006.

We appeal to all our members to write yet another submission – this time to Industry & Investment NSW to reject this demolition proposal and to further explore a range of possible adaptive uses and methods of administration for the jetty. Attached is a form letter that you may wish to use, but of course you may also add your personal comments or write your own submission.
