Report on Coal & Allied - Middle Camp Development

C&A are lodging their Development Application in the next couple of weeks with documents to be displayed in the Bowling Club / Community Hall. The Association members and community at large will need to view these documents, formulate questions so the community can meet with C&A as part of the consultative process.

Report on Rose Group Development

Sue Whyte and Damien Hawcroft and been invited by Nick Jackman (Senior Development Manager – RoseGroup for this project) to participate in the Bay Community Liaison Committee, 1st meeting held at the Surf Club, 17th March. The purpose of this Committee is to help inform the community and other stakeholders of activities taking place with the development. Feedback will be provided to the community via Progress Association meetings.

News Flash

- There is concern over the rapid deterioration of the Tennis Court owned by C&A and a letter is being sent by the Association to C&A to undertake repairs. Destruction by neglect will see the loss of this important community facility. Association members would be keen to partner with C&A in this project.
- A new draft Development Consent Plan for the Bay is being prepared by LMCC. Lisa Wrightson from LMCC is seeking a number of meetings with stakeholders to hear their concerns followed by a draft. Stakeholders are the CHBPA, C&A, RoseGroup, and community at large. Our meeting is planned for 28th March and anyone from the Association is welcome to attend, for details please contact Sue Whyte.

- After October 2013 fires, spot / chitter heatings continue to burn and being managed by LakeCoal. This work is difficult but hopefully should be all out within the next 4 weeks. - Jennifer Hill and Sue Whyte have met with the National Trust and the Heritage Office concerning a rebuild of the destroyed heritage houses. In Australia this is not required but what is built will have to stick to the same footprint and be no higher than the building that was destroyed by the fire.
- On request from the Association, Robyn Parker (Minister for the Environment and Heritage) has arranged to have Association members meet with representatives from the Environment and Heritage Department, April 2014.
- The Association wishes to thank LMCC for installation of a new fence around the Slaven Park / BBQ area. Hopefully, next will be more shade cover for the seats!
- The Association has made contact with a number of people who lived in the Mine Manager's House and the Winding House. Some wonderful old photographs have been gathered and 3 oral histories carried out. The Association intends to publish a booklet on the lost heritage houses. The archaeologist, Lorraine Nelson who has prepared a report on the Winding House on behalf of C&A, will be forwarding us a copy.



General Business

- The CHBPA is to write a letter to Peter McMurray from LMCC re; progress of implementation of the traffic calming measures.
- A letter to be sent to LMCC to determine who now owns the land around the cemetery. Garbage bins and toilets are badly needed.
- Need to establish ownership of land on the cnr of Flowers Drive and Lindsley and who is responsible for the maintenance of this land. Sue has undertaken to speak with Greg Field from LMCC after the Community Consultation Panel meets next Monday 17th March.
